**RELEASE, COVENANT NOT TO SUE AND INDEMNITY AGREEMENT ("RELEASE")**

**I. Agreement**

Program held on May 6, 2022 and May 7, 2022 in Sheboygan, WI. This event is sponsored by Great Lakes Spaceport Education Foundation, Inc, Sheboygan Area School District, and the City of Sheboygan.

Rocketry, including the preparation, launch and recovery of rockets, involves risks, dangers and hazards that may cause serious personal injury or death and that injuries are a potential occurrence. Risks include, but are not limited to, propellant burns, electrical shock, damage from impact of a rocket or rocket parts, and burns from grass fires. I agree that the above-named sponsoring parties have taken all reasonable precautions necessary to protect me from the known danger inherent in launching rockets; however, the risk of accidents involving such inherent dangers exists, regardless of safety precautions. I also acknowledge that I may be exposed to other unknown hazards associated with this and other operations at the launch site in Sheboygan.

In consideration for the above named sponsors permitting me to participate in the tour and rocket launch activities at the City of Sheboygan launch site on the west end of the South Pier and the Armory in Sheboygan, I, for myself, my heirs, administrator, executors, and assignees, hereby covenant and agree that I will never institute, prosecute, or in any way aid in the institution of prosecution of, any demand, claim, or suit against Great Lakes Spaceport Education Foundation, Inc./Rockets For Schools Program ("GLSEF") or its sponsors the Sheboygan Area School District, the City of Sheboygan, the Wisconsin Department of Transportation, the U.S. Coast Guard, the Sheboygan Area School District and the City of Sheboygan, Wisconsin, and each of their respective directors, officers, agents, contractors, employees or any persons using facilities in conjunction with the launch in Sheboygan, Wisconsin acting officially or otherwise ("Sponsors", and together with GLSEF, the "Released Parties"), for any loss, damage, or injury (including death ) to my person or my property which may occur from any cause whatsoever as a result of my participation in this activity.

If I should demand, claim, sue, or aid in any way in such a demand, claim or suit, I agree to indemnify the Released Parties for all damages, expenses, and costs they may incur as a result thereof. I understand and agree that I am assuming the risk or any personal injury, death, or property damage that may result while participating in this activity, including those that may be caused by the negligence of the above-named sponsors.

In accordance with Wisconsin law, nothing in this Release should be considered as releasing, discharging or waiving any claims I may have for reckless or intentional acts on the part of any Released Parties. The undersigned agrees that ANY CLAIM for injury and/or death against any Released Parties shall be governed by the laws of the State of Wisconsin.

I HAVE CAREFULLY READ THIS RELEASE AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS RELEASE, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE RELEASED PARTIES AND THEIR OFFICERS, AGENTS, DIRECTORS, AND EMPLOYEES FOR CERTAIN CLAIMS. I UNDERSTAND I AM ABLE TO EXERCISE THE OPTION TO DECLINE TO EXECUTE THIS RELEASE, BUT THAT I MAY NOT BE ABLE TO PARTICIPATE AS A RESULT OF SO DECLINING.
